3. Supervising the Executive Board by the Board of Directors:

The supervision of the activities of the Chief Executive Officer and the members of the Executive Board in the first 6 month of 2026 was carried out by the Board of Directors in accordance with the provisions of the Charter, Regulations, and applicable laws:

- A member of the Executive Board, concurrently serving as a member of the Board of Directors, presided over monthly coordination meetings; summaries of which were forwarded to the Board of Directors for their review and guidance to ascertain the contemporary circumstances, thus facilitating the timely achievement of approved business objectives.
- Proposals from the Executive Board were thoroughly discussed within Board of Directors' meetings or, for issues arising outside these routine gatherings, were examined through formal written opinions. Subsequent to Resolution or Decision pronouncements, the Executive Board duly executed all matters and reported progress along with resultant outcomes of their assigned responsibilities.
- Closely monitoring the company's business operations and financial situation through periodic reports on business activities and financial performance submitted by the Executive Board; maintaining regular communication with Executive Board members concurrently serving as members of the Board of

Directors; supervising and evaluating the achievement of monthly/quarterly objectives and plans through periodic reports.

- Board members attended a recap of operations within an official midpoint annual 6-month business discussion assembly, timely directional dictates and anticipatory guidance, which would shape future business designs in the first 6 months of 2026.

In general, throughout the operational process, the Executive Board has strictly adhered to the governance hierarchy and directives of the BOD as set forth in Bao Minh's Charter, Corporate Governance Regulations, internal rules, and BOD Resolutions and Decisions to successfully fulfill its operational role in alignment with the BOD's orientations. For matters exceeding its authority, the Executive Board promptly submitted reports and requested guidance from the BOD for implementation, striving to accomplish all set goals.

3. Supervising the Board of Directors, the Executive Board and shareholders by the Board of Supervisor:

Based on prescribed authority and responsibilities, the Board of Supervisors oversaw the Board of Directors, Chief Executive Officer and the Executive Board in their management and operation of the Company, specifically: :

- Supervised the organization of Board of Directors' meetings; the issuance of Resolutions and Decisions of the Board of Directors; the preparation and execution of the Annual General Meetings of Shareholders for 2026 of Bao Minh Insurance Corporation, as well as regular and extraordinary meetings of the Board of Directors.
- Supervised the execution of Resolutions from the Annual and Extraordinary General Meetings of Shareholders for 2026, as well as Resolutions and Decisions enacted by the Board of Directors during 6 months of 2026;
- Supervised the operations of the Board of Directors, Chief Executive Officer and the Executive Board's operations in managing the activities of the Bao Minh Insurance Corporation during 6 months of 2026.

Through supervisory activities, the Board of Supervisors noted that members of the Board of Directors, the Chief Executive Officer, and the Executive Board have been proactive, energetic, and dedicated to fulfilling their duties in corporate governance and management. The Executive Board has also issued specific and timely directives and guidance to resolve outstanding issues. In the first 6 months of 2026, total system-wide revenue is estimated to reach over VND 4,093 billion, representing a year-on-year growth of 14.72% and achieving 56.39% of the annual plan, exceeding the average progress approved by the General Meeting of Shareholders; profit before tax is estimated at VND 221 billion, reaching 65.1% of the target profit and increasing by 26.09% compared to the same period last year.

Resolutions and Decisions on governance and operations issued by the Board of Directors and the Chief Executive Officer are consistent with practical conditions, satisfying the governance requirements and business development needs of the entire Bao Minh system, while ensuring that the legitimate rights and interests of Shareholders are fully and properly observed.

- To effectively perform its duties, the Board of Supervisors regularly communicates with functional departments: the Company's Divisions/Centers/Internal Audit and Inspection Department, the Internal Audit Department directly under the

Board of Directors to promptly grasp information regarding the governance and operation of the Board of Directors and the Executive Board.

- The Board of Supervisors directly conducts inspections and supervisions of business operations at some member units to grasp the situation and make recommendations and proposals regarding existing shortcomings, difficulties, and limitations in the management and operation at these units.

- During the process of organizing, inspecting, and supervising management activities and the Company's production and business operations, the Board of Supervisors has been provided with all relevant documents and information in a complete and timely manner, in accordance with the Charter and internal regulations of the Corporation.

5. Other activities of the Board of Supervisors

- Submit to the 2026 Annual General Meeting of Shareholders for approval in principle regarding the selection of an independent audit firm to audit the 2026 Financial Statements of Bao Minh Insurance Corporation, and execute all necessary related procedures to complete the selection of the independent audit firm for auditing the 2026 Financial Statements and the report on the separation of equity capital and premium funds of Bao Minh.
